7. CHANGE OF FINANCIAL YEAR AND AGM DATE

7.1 Proposal to change the club financial year from April - March to January – December

7.2 Proposal to move the AGM from October to April/May

David Bull talked through the rationale behind the desire to change the year end. Primarily because the current AGM timing and the need to ratify fees for the following year are not well timed.

David explained that the committee feel it is better to have the AGM in early season April/ May and have the year end run for a calendar year 1st January to 31st December.

This was proposed by the David Bull and seconded by the whole committee. A vote was taken and the meeting unanimously voted in favour.

As a result of this – item 6, was deferred until the 2022 AGM which will be held in April/ May 2022.

8. COUNTRY MEMBERSHIP – PROPOSAL TO CHANGE THE CRITERIA WHICH NEEDS TO BE MET

David Bull set out the issue, as follows;

The problem statement

We have a category in Country which was initially designed for people to have 'temporary' membership, whilst they were in Bournemouth (visiting/holidaying etc). Demand for some kind of temporary membership still prevails, but the existing group contains members who are not temporary members, and who play all year round. So people are playing all year round, some more than once each week, yet paying a reduced membership fee. We have to ask ourselves - why are they not paying the full fee?

The proposal

Redefine Country membership as being for anyone who plays up to 26 weeks in the year and no more, AND who lives further than 25 miles from the club. Implement this change for the next membership year (2022/23).

David Bull explained this to the meeting, and used himself as an example as the current criteria allows him to be a Country Member, however as he is in the area nearly every week he can play twice a week pretty much throughout the year.

The proposal, proposed by Colin Gilbey, seconded by the whole committee, was put to a vote and the meeting voted unanimously to accept the proposal.

Chairpersons report for AGM 18 October 2021

This has been a very turbulent 12 months for Southbourne Tennis Club which has mirrored the difficulties faced by us all in life in general.

Unfortunately, one of my first tasks was to close the club in November due to the second lockdown. We were open briefly in December followed by a much longer closure from January to April. I would like to thank all our members and the coaching team for their patience during our closure and for helping us to open up safely by following the rules that had to be put in place.

Thankfully things have improved over the summer and we are almost back to “normal”.

During the winter Dave & Matt took the initiative while the club was closed and carried out a large amount of maintenance around the club. This included painting the interior of the club house, painting the practice wall and repairing and painting the wooden fence by courts 1-3. They also carried out many minor maintenance tasks that have largely gone unnoticed but are essential to the look and feel of the club. The committee are very grateful for their foresight and commitment to the club.

The club has also invested in new nets and new furniture (chairs & tables) inside the club house to improve the member experience.

As part of our commitment to the health and safety of our members and coaches a comprehensive review was carried out by one of our members, Paul Woods. A large number of improvements opportunities were identified and the committee has been working their way through the list. As part of completing many of these maintenance and improvement tasks, in the absence of volunteers, the committee took the decision to employ someone to help us. We were put in contact with a handyman, Colin Reeves, who has been working his way through our list of jobs. We are now in a position to carry out preventative maintenance rather than being purely reactive to situations.

In addition, we have had the compost heap/dump removed from the side of the shed along with two large trees (one was dead and the other was in a very dangerous condition). Some other minor tree pruning took place and we are awaiting a response from the council to prune trees that are impinging on courts 5 & 6.

When lockdown ended we were unsure how the club would recover from being closed over the winter. We were pleasantly surprised that the membership has actually increased with a large number of adults who are returning to tennis joining the club. The coaching team have been very busy during the summer with courses being full across the spectrum of adult, junior and disabled coaching. Although this has sometimes put pressure on the availability of courts it is good to see the club being so vibrant and busy every day of the week.

It is interesting to see how adult usage of the club has changed. The constraints on play early in the summer have led to a larger number of “fixed 4s” taking place compared to lower attendance at scheduled club sessions. Attendance at the Monday and Tuesday mornings has fallen along with the Friday morning session. This has been offset to some degree by a slight increase in usage in the evening

sessions. The committee will monitor the situation and manage the availability of courts for club sessions to optimise usage of the club.

The Southbourne Open run by Zoltan was very successful with over 80 players attending. The Southbourne Closed tournament has been a bit of a headache with a significant number of players leaving matches to the last minute causing many matches to be conceded. It may be necessary to change the format, duration or time of year to try to ensure a more successful tournament in 2022.

Match tennis has been disrupted over the last year. Fortunately the summer leagues have taken place this year within the constraints in place at the time. Thanks go to Celia for ensuring our team captains have courts booked and know where and when they should be playing matches. I cannot imagine the number of emails and phone calls required to make sure things run smoothly.

An additional offering at the club has been Pickleball. This is a padel game that is played on a small court. We have marked out a court on the existing "mini tennis" court. All equipment can be borrowed from the club if you want to give it a try.

Our major project for the year was the installation of the new flood lights. I would like to thank Colin Gilbey for his efforts in managing this project from conception, tendering and supplier management to turning the lights on. The new lights should provide a more even lighting pattern for players and a large reduction in running and maintenance costs for the club. The project was done in record time with disruption being limited to 5 days. We would also like to thank the Dorset LTA for a grant to help with the cost of installation.

Another large project is due to commence at the end of September and will hopefully be finished well before the AGM. This is the surfacing of the car park near courts 5 & 6. While this will be very disruptive we hope that the outcome will be worth it.

So what is planned for the next 12 months?

The main project that we are planning is the court 1-3 resurfacing. It is likely that this will be carried out in August 2022. Again this will be very disruptive for approximately a week but we need to invest in our infrastructure to provide the facilities our members deserve.

We will also be replacing our outdoor furniture to enable us to socialise in a pleasant environment.

There will also be a survey of members views issued during the winter. We would encourage all members to return it either with suggestions on how to improve the club or just to say you are happy with the way things are. We cannot guarantee to act on all suggestions but they will all be considered.

We have been unable to hold any social events over the last year so it is really positive that we have booked a Christmas Party for Saturday 11th December. I hope that many of you will be able to attend and celebrate the end of a very difficult year and look forward to a more normal 2022.

Finally, I would like to thank the committee, Dave Sanger and the coaches for all their hard work behind the scenes to make Southbourne Tennis Club a great place to play tennis. I would also like to thank all the volunteers that have helped us run the club during the last year from supporting tournaments with catering, helping out with junior tournaments and coaching and doing the gardening to keep the grounds looking nice.

Head Coaches Report for AGM 2021

It has been a mixed year for Southbourne Tennis Club and for the coaches. Covid lockdown took away Jan-March where all coaching was put on hold all over the Spring term. However, since April we have seen a steady rise in tennis and particularly players on the coaching programme. We appreciate all the support from the club and the regular tennis players who are still keeping up with their lessons.

This year we have tried to continue to sustain most of our Disability Tennis Programme and community Tennis Programme. This has continued to give the opportunity to people who may not been able to access the sport. Southbourne Tennis Club is still a leader in disability tennis in the county and the country.

We have been part of the LTA Tennis Start programme giving around 30 new children a chance to play tennis for the first time and 12 new adults. New walking tennis session added for Adults.

We have also been part of a BCP Initiative to get more people active and giving an opportunity to have a go at tennis. We hosted 2 demo days, one at Christchurch Quay and one at Churchill Gardens which were both a massive success and lots of people playing tennis.

We also had a demo coaching day for members with Bright Ideas Tennis charity who came along with Danny Sapsford and Lucy Shuker (Silver medallist at the Tokyo Paralympics). This was a great success.

A big thanks to Zoltan Horvath, Matt Sanger, Ray Burningham, Liana Hodgson, Laura Phillips, Sarah Males, Emily Pardy, Tom Birch, Matilda Brown who all help with the coaching, running tournaments and the disability programme at the club. More volunteers are always welcome.

This report details more news from the rest of the year.

[Junior Club Sessions](#)

Saturday Morning 10-11am & Monday Night 6-7pm

Aims of session:

To keep children active for 1hours. Improve knowledge and skills of tennis.

Objectives:

The sessions are run offering fun competition and fun games making the sessions fun and challenging. There has been a high of about 20 children turning up on Monday evenings. Ultimately juniors will be able to progress from the Improvers group to the Intermediate group, from the Intermediates into Junior Teams, from Junior Teams into Senior Club Sessions (with approval from Coaches and Committee), from Senior Club session to play in Senior Matches for the club.

[Adult Groups](#)

These groups are based around standard. These are open to all members to help improve their tennis skills and knowledge.

There are currently around 55 adults taking part in these groups ranging from beginners, improver to advanced and from 18 - 90. Also, cardio tennis has around 8 adults taking part.

Aims:

Improve standard of adults, Improvement of knowledge of performance factors. which involves technique, tactics, mental and physical parts of tennis.

To improve competition in club. Improves standard of tennis being played and will lead to more players involved in the club and coaching programme.

Objectives:

Help players improve technique, tactics, mental and physical parts of tennis. Progress players into club sessions, into teams and into club tournament.

There has been a steady increase of adults playing more regularly and enjoying their tennis.

[Junior Squads](#)

These groups are based around standard and age. These are open to all junior members to help improve their tennis skills and knowledge. Each group will on average have no more than 8 children per coach.

There are currently around 40 children taking part in these squads ranging from junior improver to junior performance.

Aims:

Improve standard of children aiming at Club to County standard if not higher.

To improve general competition in club. Improves standard of tennis being played and will lead to more performance players involved in the club coaching programme.

Objectives:

Improvement of knowledge of performance factors which involves technique, tactics, mental and physical parts of tennis. Players progress into junior teams and ultimately into Senior Club play and teams.

Starting with numbers; Mini Tennis Term Club Membership for all Under 10's is included in coaching course fee & Total numbers for the year for Mini Tennis Members was 120.

We have been hard at work increasing the number of children under 10 participating in Club coaching sessions and in Mini tennis events. This has also aided in strengthening our links with St Katherine's School, St Peters Primary School. We have over 40 players in our school's programme.

The disability work is going well. We were chosen to do an interview on BBC South Today and appeared as a case study on the LTA website.

Starting with numbers; Total number playing over a month is now 109 - 48 adults / 61 children.

This breaks down to;

Impairment specific groups;

14 adult / 8 children physical/wheelchair players, (1 adult transplant player, 6 walking tennis, 7 Adult wheelchair players, 2 Junior wheelchair players, 6 wheelchair players from Victoria Centre.

20 Adult / 48 children Learning disability players, (2 adult learning disability mainstream, 18 people for our P&P LD session, and 28 from Linwood Schools and 8 with SCARF children's group. DS Active Children's Session added with 8 attending, 8 players with Lifeskills Autism Portfield School, 4 children Learning disabilities)

10 Adult Mental disabilities, (Boscombe Day centre 4 players, Stourcliffe Home 3 players, 3 adult mental dis/dementia)

3 children Visually impaired players.

2 Adult / 2 children deaf players

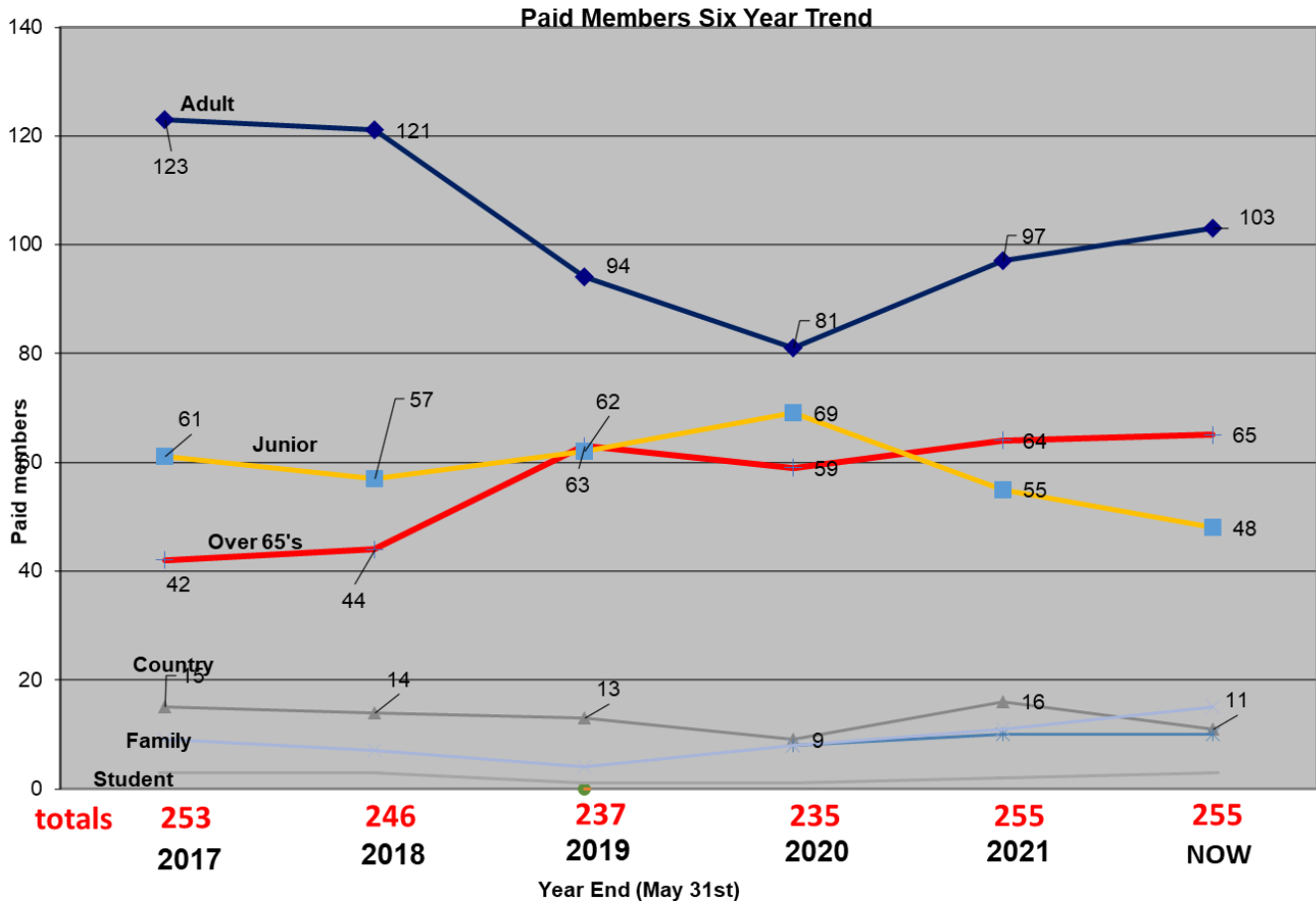
