Receipts and Payments

Repairs were high in Nov due to payments made to Colin Reeves for installing new gravel boards.

Other expenses include £180 Local Giving annual subscription and the excess cost of the

Xmas Party of £162. I also attach a schedule showing the actual for the year compared to

the original budget.

Overall the closing bank balance is ± 600 better than expected but the sinking fund is down by $\pm 2.7k$.

Year End Accounts

I attach a draft Balance Sheet and Profit and Loss Account for the Year End Statutory Accounts. These show a profit for the year of £10k compared to a loss for the previous period of £4.8k (however this was after incurring car park repairs of £19k).

<u>Budget</u>

I attach my budget for 2023 and a schedule showing the basis for the membership income. No increase in fees has been included in my budget.

Overall net income is £19.6k giving an increase in club funds of £5.2k

Committee Thoughts

We discussed the management accounts and budgeting for 2022-23 and agreed everything is in good order.

Budgeting and membership costs for 2023-24 were discussed which resulted in a number of actions to be taken.

DS and CG will look at possible membership dropouts for 2023-24 to help budgeting. CG will attend a membership seminar and try to investigate what other clubs are proposing for membership cost changes.

Proposed Changes to the member information pack.

For background - when any new member joins the club, once their fee is paid, I send them a 'new member' greeting email. This email has an attachment, which is the Membership Info Pack. There is one for Juniors, and one for Adults.

The Adult pack contains references to the Membership Cards, which we used to give every member, but which recently we decided to do without until further notice. I therefore need to update the Adult pack, and change the wording, which the committee subsequently needs to agree.

Proposal;

Old Wording

Club sessions need to ensure that everyone has equal access to the courts and equal court time. This is particularly true when there are players waiting to play, so like many clubs we operate a 'peg board' system. Each member has a named membership card, which needs to be placed on the peg board as soon as the member arrives.

You place your membership card in the waiting area if you are waiting to play, and move it to the pegs for the relevant court when you go on-court.

Established members will be pleased to explain how the board process works, and you will I am sure pick it up quite quickly. It is only by using the board properly that we can be fair to all members, and ensure everyone gets their share of available court time.

And don't forget to take your card with you when you go home!!

New Wording

During club sessions we all need to ensure that everyone has equal access to the courts and equal court time. This is particularly true when there are players waiting to play, so it is important that players leave the court when their set has been played and return to the patio/clubhouse area, in order to await their turn to play again. Priority must always be given to any member who is waiting to play, especially if they have not yet played at all in that session.
